The "Quarantine for Late Blight" details cull pile management requirements in the summer from June 1 through September 10^{th.} Cull potatoes are to be destroyed within 72 hours utilizing one of these methods: composting, ensiling, processing, burying, or using for livestock feed with certain conditions. MARKETING UPDATE

COLORADO DAIRY AND IRRIGATION EFFICIENCY

On April 27th, the Colorado Energy Office (CEO) announced that it was selected for a \$1.1 million U.S. Department of Agriculture (USDA) award to help finance energy efficiency improvements for Colorado farmers. This is great news for farmers interested in taking advantage of the free energy audits this program provides. CPAC hosted a meeting in February where several growers signed up for their audit. Energy use accounts for 7-8 % of the average farm's annual operating expenses.

CLIMATE SMART AGRICULTURE

Water is the life blood of western agriculture and the future of irrigated agriculture is at stake in a state that is predicted to increase to an estimated 7.8 million people by 2040, and increase of nearly 2.3 million. What will the impact be if it is drier and warmer? Last week Colorado State University hosted a forum on Climate Smart Agriculture. The forum addressed how climate change and increasing weather variability will impact Colorado agriculture in the future. The discussion focused on how Colorado State University can utilize its resources to work with the Colorado agriculture sector to address the many practical science-based dimensions and management strategies of increasing weather variability. GMO LABELING

Senate Agriculture Committee Chairman Pat Roberts (R-KS) and ranking member Debbie Stabenow (D-MI) say they are working to come up with legislation to preempt Vermont's GMO labeling law from taking effect July 1. If they don't the Vermont law essentially becomes the de facto labeling authority for the United States. The current impasse is over how information on the presence of GMOs in food and food products will be relayed to consumers. Many labeling options have been proposed including "smart labels" consumers could use their phones to access. The reality is not whether congress believes GMO technology is safe because FDA, EPA, and others have said it is but if consumers have the right to know what is in their food, regardless of safety concerns. According to The Des Moines Register, Sen. Chuck Grassley (R-IA) recently stated that there is zero chance Congress will finish a bill before July 1 on this issue. Unfortunately an issue that shouldn't be partisan is now highly partisan with Democrats generally supporting mandatory labeling and Republicans supporting a voluntary labeling approach.

RESEARCH

Thanks to Andrew Houser for his article on his cover crop research. The CPAC research sub-committee is continually working to develop information to help our growers improve their soil health and cultural practices and this is a great example.

BUILDING A BETTER COLORADO

In the summer of 2015, a nonpartisan group of Coloradans came together with a shared concern about the direction our state was heading in three critical areas: the ease with which the constitution can be amended; the decreasing participation and confidence in our election systems; and the imbalance between citizens' expectations of services that their state government provides, and the ability of their state government to meet those expectations. Their stated goal was to engage Coloradans in discussions of those issues in order to create a better Colorado. The forum which they created to host this

conversation was a new non-profit organization called "Building a Better Colorado".

From August 2015 through January of this year, representatives of Building a Better Colorado met with more than 2,000 community leaders and concerned citizens in over 30 meetings held throughout the state. The intent of Building a Better Colorado was not to dictate solutions, but instead to engage people across the state in conversations about the challenges we face and to come up with consensus solutions.
