2019 NPC POTATO FLY-IN the Fly-in is February 25-28th in Washington, D.C. Potato growers and industry leaders will listen and learn as featured political and policy speakers address key issues facing the potato industry. Attendees will meet with administration officials from the U.S. Department of Agriculture and the Environmental Protection Agency. The Fly-In culminates with attendees taking to Capitol Hill to lead the industry's grassroots advocacy efforts. The CPAC committee will assist a limited number of growers with registration and lodging for the Fly-in. Please contact the CPAC office if you are interested.

UNITED POTATO GROWERS OF COLORADO October 2018 Market Update-Preliminary reports indicate the nation will be down about one million cwt in fresh supply as we start the 2018 shipping season. Washington State has more processing contracts and more of the historical fresh supply has been designated as processed supply. Wisconsin is facing a dire year due to poor weather at harvest with an estimated 30% of the crop left unharvested. Idaho has a healthy crop and will fill the fresh void left by Washington and Wisconsin. Colorado supply is estimated to be one million cwt over last year however we are receiving reports of pink rot and leek which may bring our estimate down to historical shipment numbers. The Nebraska-Northeast Colorado production is down slightly and Texas is reporting the largest fresh market crop on record. Canadian supply will also be down from previous years due to the same weather patterns that affected the Wisconsin crop.

RESEARCH NEWS The research sub-committee has held two meetings already in November and will meet again on November 19th. They are working to develop a list of research project priorities so that the CPAC committee can issue a call for request for proposals for research.

Several members of the industry also attended a Specialty Crop Research Initiative planning grant workshop concerning the future of potato breeding. The meeting included public and private potato breeding expertise from across the nation. The information gathered will be used to pursue a SCRI grant to further the development of diploid potato breeding.

The new potato pathologist Dr. Cheks Mattupalli has arrived at the C.S.U. Ag. Research Farm and has hit the ground running. He attended the CPAC meeting in October, the research sub-committee meeting and has been out meeting growers and industry nearly every day. We are excited to have him on board.
