NEXT CPAC MEETING The next meeting of the Colorado Potato Administrative Committee (area II) will be held January 23rd at 7:00pm, in the CPAC office conference room.

CDA Are you planning to bring seed into the San Luis valley from outside the area? You must follow the rules established by the Late Blight quarantine (LBQ). The LBQ insures all seed imported into the SLV must be certified and accompanied by 1) a certificate that shows proof of field inspection, 2) a North American Plant Health Certificate issued by the certifying authority for seed potatoes where the seed potatoes were grown, and 3) laboratory test results documenting that a representative sample of tubers from the load(s) was tested for late blight. Imported seed shipments must be re-inspected during the unloading process to verify the absence of Late Blight symptoms. For imported seed rules: LBQ Rules please contact the Fruit and Vegetable Inspection Service at (719)-852-4749 with your questions.

LIVESTOCK FEED If you are feeding potatoes to livestock please report the cwt. to the CPAC office so we can update crop disappearance. This information is relevant for market supply and market prices.

The Colorado Agriculture Leadership program is pleased to once again host the Governor's Ag Forum at the Denver Renaissance. This year's theme is "Brand It Agriculture", promises a day full of networking and discovery of what lies on the horizon for our state's second-largest economic driver. POTATO RESEARCH the CPAC research sub-committee will be meeting January 9th. The agenda includes results reporting on our soil health block grant project, priority discussion for 2020 projects, CSU Shared Commodity Challenge grant, and potential 2021 block grant projects.

NPC This week the U.S. Senate Finance Committee will take up the USMCA agreement that passed the House in late December. Long supported by NPC and a coalition of over 300 farm, ranch, and agriculture groups, USMCA builds on the North American Free Trade Agreement (NAFTA). Under NAFTA, U.S. agricultural exports to Canada and Mexico have more than quadrupled over the last 25 years. Canada is the second largest export market for U.S. potatoes and Mexico is the third largest export market for U.S. potatoes. The passage of this agreement and a potential Phase 1 trade deal with China is good news on the trade frontlines. As we report often 1 out of every 5 rows of potatoes grown in the United States are exported so trade is critical for our industry.

The CPAC committee is grateful to the members of the Colorado House of Representatives who supported this agreement and the Farm Workforce Modernization Act (FWMA) that also passed the House in December. In particular, we are grateful to Rep. Scott Tipton for his support of this legislation and his ability to see the urgent need for solutions to the labor shortage in agriculture and act accordingly.

We will have an advertisement slot on chair lift screens and screens throughout the resorts of Winter Park, Steamboat and Telluride. Our first round of ads began on January 4th and will run through the month of June. We're excited for the potential reach and awareness that this campaign will bring! POTATOES USA Potatoes USA is actively working to redefine potatoes as a "good carb," and high-profile media outlets are taking notice. NBC News and WebMD recently released articles discussing the high nutritional quality of potatoes.

On November 26, NBC Better published an article titled "<u>5 seemingly unhealthy foods that are actually good for you</u>," which has a potential reach of 42.7 million individuals. Author Samantha Cassetty, a registered dietitian and contributor to NBC Better, noted potatoes at the top of her list. She wrote about the nutrients of potatoes, including fiber and potassium, and the beneficial resistant starch they contain. Cassetty also discussed the wide range of potato varieties available. Sally Kuzemchak, a registered dietician and contributor to WebMD, wrote an article titled "Potatoes are Making a <u>Comeback</u>," which was posted on the WebMD blog on December 5. She wrote about the addition of potatoes to the WW (formerly Weight Watchers) and Whole 30 plans, key nutrients in potatoes, and healthy ways to prepare them. This article has a potential reach of 5.1 million people and was already shared in a Nutrition and Dietetics Smartbrief and an e-newsletter sent to members of the Academy of Nutrition and Dietetics. Moving forward, Potatoes USA and influencers will continue to amplify the "good carb" message of potatoes by sharing these articles on social media and reaching out to relevant media who are interested in potato information and research.
