Growers interested in applying for an exemption to the Seed Potato Act must submit their request to the Seed Law Advisory Committee through the CPAC office. If you need information on applying for an exemption please contact Jim for more information. It is important to know that any lot approved for an exemption must have a four hundred tuber sample tested and confirmed to be free of Bacterial Ring Rot and Late Blight. RESEARCH

The CPAC research sub-committee met on February 21st for presentations on seventeen research concept proposals. Researchers briefly presented their ideas and budget at this meeting with limited time for Q&A from committee members. The committee then met on March 2nd to discuss which projects to ask to submit full proposals. The committee invited eight researchers to submit proposals for thirteen projects. These proposals are due March 20th. The committee will then score the proposals and prioritize funding. This year the funding requested was over \$480 K. Last year the CPAC committee \$247,750 to research projects and secured \$162,960 in additional research funding through specialty crop block grants and the Colorado State University Shared Crop Commodity Challenge grant program. The deadline for the NIFA grant that CPAC was awarded is April 2nd. We are hopeful that we will receive proposals that we can support.
