POTATO ACRES 2020

The potato fly-over has been scheduled for June 22nd. CPAC will work closely with NASS to ensure that the acreage count is as accurate as possible. According to North American Potato Market News potato acres are estimated at 908,000 acres in 2020 which is a 6.2% decrease form 2019. Idaho acres are projected to be down 4.8% at 295,000 acres. In conjunction with the CPAC acreage fly over **United Potato Growers of Colorado** is conducting their count too. Please submit your farm map with acreage by variety to Lyla at United Potato Growers or the CPAC office. This data helps build a database of historical information and trends in color and varieties produced in the SLV as well as verify the fly-over acreage count. POTATOES USA

Potatoes USA CEO Blair Richardson just introduced their newest communication tool, "Keeping It Current", a periodic video series with short, topical conversations from the Potatoes USA staff. Richardson says, "We will provide you with current information on program activities, industry trends, challenges, and victories as we continue our efforts to defend and promote the potato industry. This will not replace the valuable conversations normally occurring when we travel across the industry. However, we do hope this will give you a few more opportunities to stay current with what we are doing and why, until we can once again travel freely and safely. Please let us know if you have any questions or any requests for future topics."

NPC EYE ON DC

The potato industry has advocated for two distinct programs to provide relief to family farms impacted by the COID 19 crisis. First, it has called for USDA to step in to buy significant amounts of oversupplied potatoes and potato products. Without these purchases, family farms will be impacted into the fall of 2021. Second, the industry has called for providing meaningful direct payment relief to growers who cannot fully benefit from surplus commodity purchases. Sign up for direct payment began on May 26th.

For potato growers, the total direct payments will be based on three criteria:

- The volume of production sold between January 15 and April 15, 2020;
- The volume of production shipped, but unpaid; and
- The number of acres for which harvested production did not leave the farm or mature product destroyed or not harvested during that same time period, and which have not and will not be sold.

The NPC has written a letter to USDA asking that they reconsider several points with the direct payment program which are making it difficult for potato growers to benefit from the intent of the program. Please contact your local FSA office if you are interested in learning more.
